## **Background:**

The Royal Commission on Health Care and Costs was established in 2000 to:

"Inquire into and undertake dialogue with Canadians on the future of Canada's public health care system, and to recommend policies and measures respectful of the jurisdictions and powers in Canada required to ensure over the long term the sustainability of a universally accessible, publicly funded health system that offers quality services to Canadians and strikes an appropriate balance between investments in prevention and health maintenance and those directed to care and treatment."

-- Commissioner Honourable Roy J. Romanow submitted his Final Report in November 2002.

In the two years that followed, the country's First Ministers agreed to two Accords that identified common priority areas for action, the 2003 *First Ministers' Accord on Health Care Renewal and the 2004 10-Year Plan to Strengthen Health Care*.

This invitational forum, hosted by the **Canadian Association for Health Services and Policy Research** (CAHSPR) with support from the **Health Council of Canada** (HCC), provides an opportunity for reflection on what led to and emerged from the recommendations made in the Romanow Report, what has occurred in the ensuing ten years, and what is still left to be done in terms of renewal and reform of Canada's health system.

## **Objectives:**

- To identify the challenges and opportunities that gave rise to the Commission recommendations and ensuing agreements and to reflect on progress made.
- To identify outstanding challenges and opportunities in major areas of policy focus, in service delivery and the role of key actors, and to identify possible paths for further progress in these areas.
- To explore how to realize Canadians' aspirations for their health care system into the future.
