What began as a desire to help those in need has evolved into a mission to improve the quality of healthcare for all Canadians. Chris Power's journey in healthcare began at the bedside as a front-line nurse. Since then, she has grown into one of the preeminent healthcare executives in Canada. Her experiences, her success, and her values have led her to the position of CEO of the Canadian Patient Safety Institute. Previously, Chris served for eight years as president and CEO of Capital Health, Nova Scotia. Chris holds a Bachelor of Science in Nursing from Mount Saint Vincent University and a Masters in Health Services Administration from Dalhousie University. She is a Certified Health Executive with the Canadian College of Health Service Executives and holds a Fellowship in Management for Executive Nurses from the Wharton School, University of Pennsylvania. In 2003, she received the Award for Excellence and Innovation from the Canadian College of Health Services Executives and in 2007 received an Award of Excellence from the

Halifax Progress Club. She was named one of Canada's Top 100 Most Powerful Women in the Public-Sector Category three years in a row from 2007-2009 and in 2010 was inducted into the Hall of Fame. In 2013 Chris received an honorary Doctorate in Civil Law from St. Mary's University. Chris holds significant governance roles including President of the Canadian Association for Health Services & Policy Research Board, Co-Chair of CHLNet, Board member of Colleges & Institutes of Canada, and Board member of Simulation Canada. Dr. Emily Gard Marshall, BA, MSc, PhD, is an Associate Professor in the Dalhousie Department of Family Medicine Primary Care Research Unit, cross-appointed in Psychiatry and Community Health and Epidemiology, a Healthy Populations Institute Associate Research Scholar, Nova Scotia Health Authority Affiliated Scientist, McGill Family Medicine Adjunct Professor, Faculty Mentor for the CIHR TUTOR-Primary Health Care Strategic training program, Board Member of the Canadian Association of Health Services and Policy Research and former CAHSPR Primary Health Care Theme Group Chair. Her mixed methods research examines primary healthcare access, continuity, and comprehensiveness in community and institutional settings with the goals of improving access equity and optimizing patient and provider outcomes. She currently leads "MAAP-NS: Models and Access Atlas of Primary Care Providers in Nova Scotia", the first Canadian study linking census provider and practice survey data to equity and comprehensiveness outcomes from billing data; "The UP study: Unattached Patients in primary care - a mixed methods understanding of causes, consequences and solutions"; and the Nova Scotia arm of the CIHR funded ECPC-Study of family physician practice patterns and preferences.

Matthew Menear is currently a postdoctoral fellow affiliated with the Institut national d'excellence en santé et en services sociaux (INESSS) and the Research Centre on Primary Healthcare and Services of Laval University. He completed his doctoral training within the School of Public Health at the University of Montreal, specializing in the organization of healthcare services. His research focuses on the delivery and organization of mental health and addiction services within primary care and on the engagement of patients and families in their care. His project with INESSS will focus on the development and evaluation of COMPAS-SM, a new patient-oriented intervention designed to promote reflexivity and quality improvement in mental health care within primary care settings in the province of Quebec.

The objective of this session is to provide guidance in conducting rigorous impact evaluation, accessible to researchers or trainees. Rationale: Randomized trials are often viewed as the gold standard for determining the causal effect of policies, programs or practices. However, the use of randomization is often inappropriate or infeasible for many practical, logistical, ethical or political considerations. With the advent of practice-based research networks, and increased connectivity of electronic health records and health administrative data, health services and policy research has a tremendous opportunity to answer important questions using non-randomized data sources. The validity and practical utility of non-randomized data to inform policy depends critically on appropriate study designs, outstanding data quality, suitable statistical methods, and accurate interpretation of results.

Effectiveness in health services/systems research requires development of specific knowledge and skills for working in partnership with health system decision-makers. - Good leadership is often taken for granted. However, with Canada's declining relative performance and fragmented innovation efforts, new approaches to leadership and leadership development are vital: old ways won't work. Growing leadership capacity is a strategic and operational priority but only in keeping with two related demands: creating healthy workplaces; and generating people-centred reform. An evidence-informed approach, tailored to each jurisdiction but tied together nationally, is desired for our health workforce. But do we have the research and evidence to support increasing leadership capacity in the health system? To begin addressing these issues, CHLNet a value network of 43 organizations, has embarked on its second Benchmarking Study on leadership gaps and the diversity imbalance in leadership. This has been done in partnership with the University of Ottawa, Canadian Nurses Association, Canadian Medical Association, Canadian Society of Physician Leaders, Canadian College of Health Leaders, Health Canada, George and Fay Yee Centre for Healthcare Innovation (MB), HealthCareCAN and Queens University. Come join us for an engaging conversation on gaps and how to create a stronger link between the users and doers of research into health leadership.

To help generate better health outcomes through improved use of data and information, CIHI has been listening to stakeholders to determine opportunities to 1) Simplify sharing of trusted data; 2) Enable privacy-sensitive access; and 3) Create insights that enable better evidence for decision-makers — from practitioners and health system planners to patients and others. Kick off your day by learning what CIHI has heard about possible directions, principles and practical actions to improve governance of data and information in Canada.
